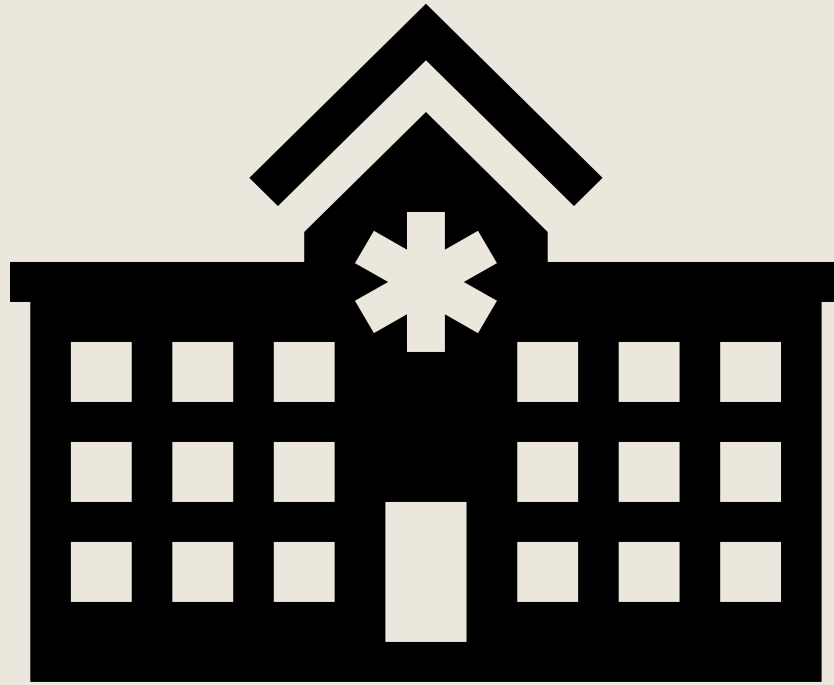

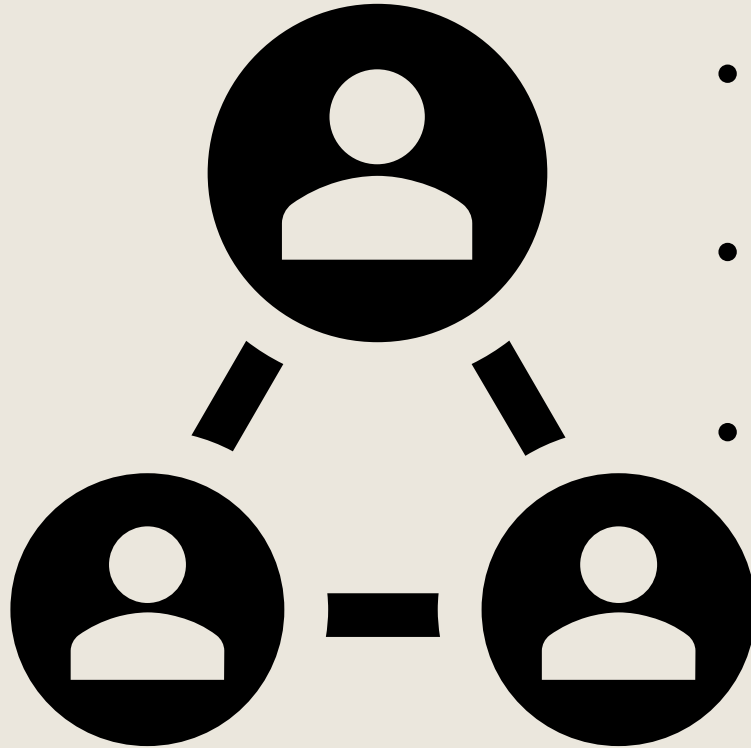

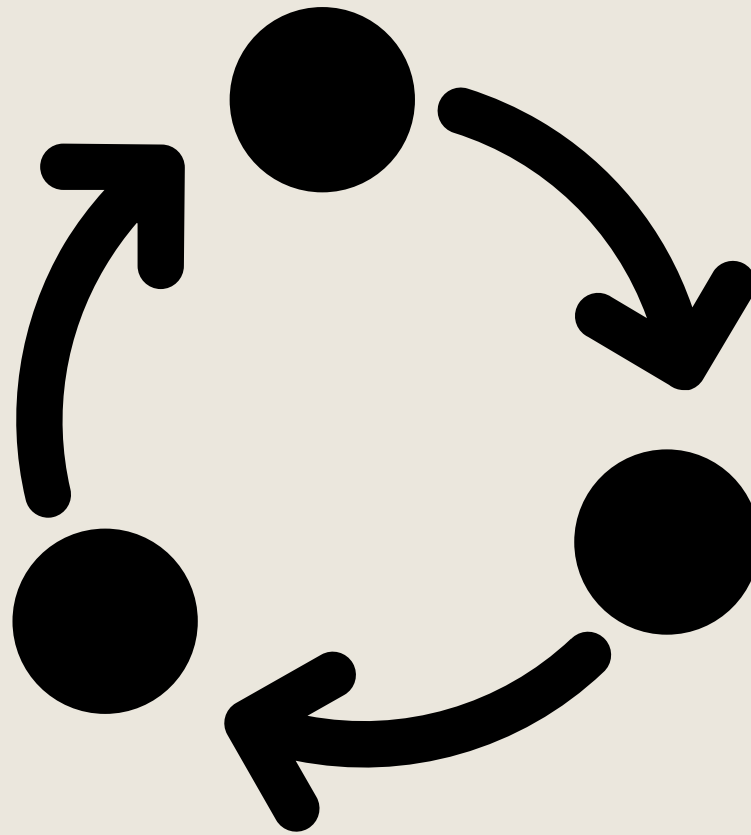


CDNY's Role with Hospitalizations

- Requires collaboration from both sides
- CDNY's role is to assist & coordinate efforts
- Early notification is key to a seamless transition

PIMI File / Name Changes

PIMI File Update – Changes in Provider Names

- Per approval from OPWDD and CCOs, MediSked has successfully uploaded the PIMI file to each CCO Sandbox sites with updates to Provider names
- Providers now appear as the Corporate Name from the PIMI file
- Previously providers would appear as the Agency name

EXAMPLE: “NASSAU CO. NYSARC INC” will now appear as “N.Y.S ARC COUNTY COUNTY CHAPTER”

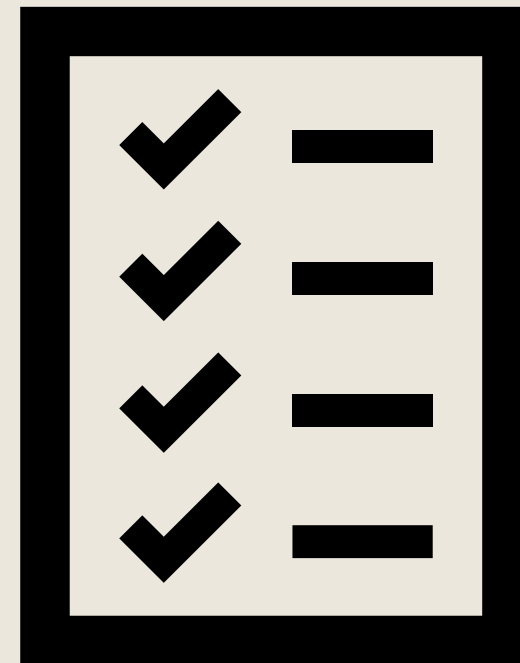


CCO Action Item: MediSked will need each CCO to review their sandbox site and approve to make these changes in production.
