# DRAFT: Reopening Guidance Plan for Site Based OPWDD Services

Care Design NY drafted a guidance document for the reopening of the OPWDD service system as we continue to live and work through an unprecedented COVID-19 public health emergency. As Governor Cuomo begins to lift restrictions and reopens New York State, we must begin planning a safe reopening of the OPWDD service delivery system.

This draft is informed by data and experiences reported by service providers, CCOs, advocates, individuals and families during the COVID-19 pandemic. A key component to the reopening plan requires answering this question: **"How do we take the best practices in service delivery that we are learning as a result of this public health emergency and incorporate those practices into models that will best meet people's needs in the 'new normal' post COVID-19?"** 

Collaboration across the OPWDD service delivery area and in the catchment areas that providers, FIs, and CCOs/HHs operate will ensure a cohesive and consistent guidance document to reopen services for the individuals and families we support. Areas of focus in this person-centered guidance document include infection control and prevention, training for the service delivery workforce, individuals, and families, transportation, personal protective equipment (PPE), community engagement, site based day services, testing/contact tracing, and financial continuity planning.
