


Address the DSP Workforce Crisis



COVID-19 Booster Doses: What You Need To Know



GET A BOOST TO FIGHT COVID-19

People who are eligible for the booster fall into one of these groups:

Should Receive the Booster:

- Individuals 65 years and older and residents in long-term care settings should receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series.
- Individuals aged 50–64 years with underlying high risk medical conditions* should receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series.

May Receive the Booster:

- Individuals aged 18–49 years with underlying high risk medical conditions* may receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series. Consult your regular health care provider. Note: The New York State Department of Health in a Health Advisory bulletin sent out on 9/26/2021 defined "Intellectual and development disabilities including Down Syndrome" as a high risk medical condition and therefore eligible for the booster.
- Individuals aged 18-64 years who are at increased risk for COVID-19 exposure and transmission because of occupational or institutional setting may receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series.

At this time, individuals must have received the Pfizer-BioNTech vaccine for their initial vaccine series at least six months ago to be eligible. Individuals who received the Moderna or Janssen/Johnson & Johnson (J&J) vaccine are not currently eligible for a booster dose at this time.

Individuals should contact their healthcare provider if they have questions about whether getting an additional dose is appropriate for them. Free booster doses are already widely available statewide at state-run mass vaccination sites, pharmacies, local health departments, clinics, Federally Qualified Health Centers, and other locations across New York State.
